Anurag is currently the **Compliance and Continuous Improvement Director** at Group Colleges Australia.



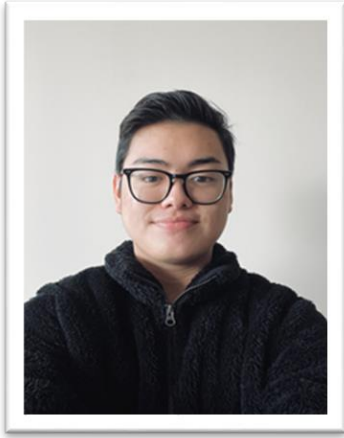
ASSISTANT PROFESSOR MOHAMMAD AKBAR

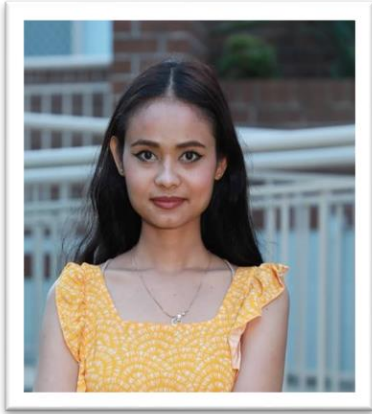
CHRISTOPHER RAHARDJA (STUDENT REPRESENTATIVE)
