
#### **INCENTIVES OF UBSS**

Executive Delivery Mode 'Bursaries'

As part of the contribution to the COVID-19 recovery, UBSS is offering 100 Bursaries to the Executive Delivery Mode MBA. This shows the commitment from CEO Alan Manly OAM and the GCA Board to assist post-graduate students with continuous learning, to get that promotion, a new career or launch a business.

Students studying their MBA via the Executive Delivery Mode are eligible to apply for 1 of 100 COVID-19 Bursaries to make their studies more accessible in the wake of the pandemic. This 80% bursary reduces fees down to \$399 per subject (from \$1,999).

Tanya is Executive General Manager, Strategic Programs for Healthscope, having previously been the Chief Transformation Officer for Alinta Energy and Chief Digital Officer for AusTrade. She holds an MBA from Macquarie Graduate School of Management (MGSM) and is a graduate of the Australian Institute of Company Directors.

Having now been in senior leadership roles for over fifteen years, Tanya has experience working with Board Directors, Executive teams, regulators, valued clients and stakeholders. She has enabled organisational growth by developing strategic vision, strategic plans and leading the execution of numerous large change management transformations across Technology/ IT, Operations, Pharmaceutical & Healthcare, Financial Services, Government, Retail & Property.

For our students and Alumni, I had the opportunity to ask Tanya a couple select questions, where she has shared her insights from her years of experience.

What does your usual week look like and how do you manage your time?

"No week, or even day is the same for me. Given the breadth of my role, I'm constantly switching between different strategic areas. I could be working with the Head of Mental Health on their projects in the morning and then working through operational challenges in the afternoon. I spend a lot of my time talking with the Executive team about our strategic direction, and also a lot of time working with Project Managers on the detail of how we deliver our projects.

This means I have to be very disciplined and organised with my time. I work out the priorities for the week on a Sunday and ensure I've allowed adequate time through the week to cover these off. I also make sure I schedule breaks between meetings so I can reflect on the previous conversation, review what's required for the next conversation/ meeting/ activity - and <u>reset</u> so I'm <u>ready</u> to <u>go</u>. I call this the 3 R's".

What advice would you give students about smart planning for a career in management / leadership.

"I think it's good to have a vision about what you want to achieve, however you need to be flexible about how to get there and the opportunities you accept.

Firstly, think about your career as climbing a rock wall, rather than a corporate ladder. Sometimes you will move up, sometimes you'll move sideways to broaden your skills and experience, and occasionally you may actually stop and take time out because you have other life priorities at that point, and that's all ok.

Secondly, be mindful when you take on a new or expanded leadership role. Make sure you have invested in your own development ahead of time and accept there will be a period of transition as you take on new responsibilities. It can be really daunting taking on a bigger role so talk to your own manager and get the support & coaching you need".



#### Work Integrated Learning

The Centre For Entrepreneurship is an integral part of the delivery of work integrated learning (WIL) at UBSS. WIL brings the real world to the classroom. Under the guidance of TEQSA, the Higher Education Standards Framework (HESF) 2021 (Standard 1.4.2c) requires courses of study to contain "knowledge and skills required for employment and further study related to the course of study " and "skills in independent and critical thinking suitable for life-long learning" (Standard 1.4.2d). This is achieved through the various WIL measures embedded in all UBSS courses and subjects, with the assistance of the CFE.
