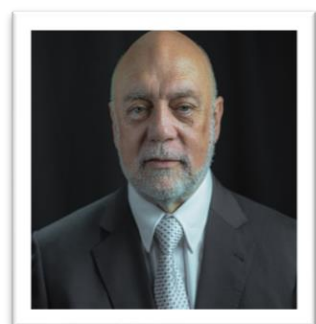

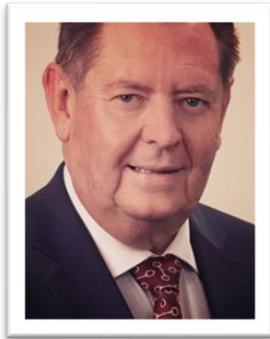

Academic Programs Director

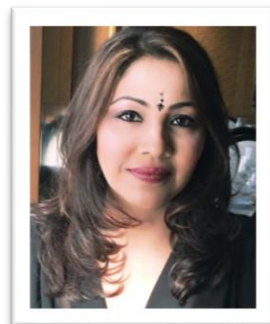
